TERMS

1. **Term & renewal.** Twelve months from countersignature. Renews at the anniversary unless either party gives sixty days' written notice. Pricing is held for the initial term and **negotiated annually** thereafter; multi-year terms available on request.
2. **Annual prepay.** The recurring fee is invoiced once, in advance, for the full term. The -2.4-month concession is the standing annual-prepay incentive applied to the recurring base; it lapses on any switch to in-term installment billing.
3. **Payment.** Net-30 from the date of countersignature. Wire or ACH. One-time setup is invoiced with the first annual term.
4. **Validity.** This quote is valid for thirty days from the issue date. After that the procurement desk will be disappointed, and will re-quote.
5. **Consent floor.** The safeword mechanism is uniform across every tier and is not a contract variable: invocation ends the scene and locks the account for twelve hours, without override. The SLA above governs availability of that mechanism, never its behaviour. See Trust & Safety.
6. **Content.** All personas are AI-generated and depict no real, identifiable human persons (18 U.S.C. § 2257 notice). Establishment use is adults-only; member eligibility is the establishment's responsibility.
